Nurse Waninger received a grant from the State which provided the administration of Naloxone in school buildings, in case of an opioid overdose. Dr. Pund described the process of training staff and the location of Naloxone. Mr. Eckert made a motion to approve the policy as suggested and Mr. Schuler seconded the motion. Motion carried 5-0.

Next, Dr. Pund referenced the upcoming summer programs for students. A list of personnel was given to Board members. Mrs. Hamilton made a motion to approve the summer school personnel and Mr. Uebelhor seconded the motion. Motion carried 5-0.
